	obituary notices and direction/supervision of services requested by the family. There is a charge for
	each service requested or required. This fee for our basic services and overhead will be added to
	the total cost of the funeral arrangements you select. (This fee is already included in our charges
	for direct cremation, immediate burial, and forwarding or receiving remains.) Deaths outside of
	Sonoma County may require additional fees.

# Immediate Burial (without formal ceremony – no family present). . . . . \$3,175.00

This charge includes a reduced fee of our Services of Funeral Director and Staff, Transfer to the Funeral Home, Refrigeration, and Transportation to Cemetery (van). This charge does not include any merchandise, additional preparation of remains, use of facilities for viewing/visitation, or any funeral ceremonies. For these and other options, please refer to the itemized section of our General Price List.

This charge includes a reduced fee of our Services of Funeral Director and Staff, Transfer to the Funeral Home, Refrigeration (the fee for refrigeration is for a 5-day period, or until all legal documentation and required paperwork has been completed by the funeral home, whichever is longer), and the Cremation by Daniels Chapel of the Roses Funeral Home & Crematory. This charge does not include any merchandise, cremation/alternative container or cremation casket, urn, additional preparation of the remains, viewing/visitation or any funeral ceremonies. For these and other options, please refer to the itemized section of our General Price List.

If you want to arrange for a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with our without an outside covering). The containers we provide are cardboard and fiberboard containers.
