You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This price list is offered to comply with the Federal Trade Commission's Trade Regulation Rule; Funeral Industry Practices 16 CFR Part 453, and Vermont (1997) Funeral Rule 5.5.

- 1. Services of Funeral Director & Staff: \$2,150.00--Includes: Twenty-four hour accessibility; general and administrative expenses; arrangements conference; planning, supervising, and coordinating service details with those involved in the funeral service; securing, preparing, and filing necessary permits, certificates, authorizations, and consents; clerical and record keeping. **This fee for our basic services and overhead and will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.** This is non declinable.
- 2. Embalming: \$595.00,
 - Except in certain special cases, embalming is <u>not</u> required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
- 3. A Other Preparation of the embalmed body: \$295.00; **B** washing / disinfecting / dressing / casketing / un-embalmed body \$395.00
- 4. Additional services of funeral director and staff:
 - A. Facilities & staff for viewing or visitation \$275.00 per hour B. Facilities & staff for private viewing during normal daytime hours or additional hours for visitation \$275.00 per/hour; C. Facilities & staff for a memorial service in the funeral home: \$600.00; D. facilities & staff for a funeral in the funeral home: \$600.00; E. Staff for a memorial service in a church of other facility: \$600.00; F. This fee is for any arranged service that takes place on a Saturday/Sunday/Federally recognized Holiday. This will not be applied to immediate need services such as transfer to the funeral home. L. Filling of 3rd party containers with cremated remains \$25.00 (\$10 for each additional) The funeral home will accept no liability or responsibility for the container provided.

- M. Refrigeration of un-embalmed remains, not to exceed 48 hrs \$75.00per day
- 5. Transfer of remains (within 25 miles) to the funeral home: \$450.00
 - **A;** Additional miles at \$3.50 per mile (one-way).
- 6. Automotive Equipment: (within 25 miles) Funeral Coach to cemetery/crematory: \$425.00; Lead Car/Flower Car/Bearer Car/Clergy Auto/Spring Autos / Service Car \$210.00; Family Car (\$85.00./hr 3 hrs/min) \$250.00; Additional miles at \$3.50 per mile (one-way)
- 7. Caskets \$1,295.00 to \$6,795.00 (A complete price list will be provided at the funeral home.)
- 8. Outer Burial Containers: \$1,675.00 to \$4,265.00 (A complete price list will be provided at the funeral home.)
- 9. Burial Urns; \$95.00 ~ \$1,595.00; **A.** Register Book (blank) \$40.00, (printed) \$60.00, Prayer Cards \$40.00 per 50ct, acknowledgment cards \$40.00 per 50; **B** Service Folders \$50.00 per 50,.**C**. set up/printing for.' memorial package 'including register book, prayer cards & acknowledgments \$125.00, **D**. lamination charge (prayer card) \$1.00 per copy, (obit / memorial card)\$3.00 per copy

- 10. Merchandise: Clothing \$25.00 to \$225.00
- 11. Forwarding of Remains to another Funeral Home: \$3,400.00 This charge includes: 24 hour accessibility; general and administrative expenses; arrangements conference; planning, supervising, and coordinating service details; securing, preparing, and filing necessary documents; clerical and record keeping; embalming; other preparation of the body; transfer of remains; use of the hearse; and Local transportation of the deceased to the airport. (Shipping Charges **Not** Included).
- 12. Receiving Remains from another Funeral Home: \$2,950.00 This charge includes: 24 hour accessibility; general and administrative expenses; arrangements conference; planning, supervising, and coordinating service details; securing, preparing, and filing necessary documents; clerical and record keeping; other preparation of the body; transfer of remains; use of the hearse; Local transportation of the deceased from the airport; local transportation of the deceased to the final place of burial; and use of staff and equipment for graveside service.
- 13. Immediate Burials: \$3,025.00 to \$12,165.00 This charge includes: 24 hour accessibility; general and administrative expenses; arrangements conference; planning, supervising, and coordinating service details; securing, preparing, and filing necessary documents; clerical and record keeping; other preparation of the body; transfer of remains; use of the hearse.
 - **A.** Immediate Burial with any casket selected from our funeral home (without any other services) \$3,025.00 Range of immediate burials with a casket from our Selection Room \$4,320.00 to \$9,820.00....**B.** Immediate Burial with a container or casket provided by the purchaser (service only) \$3,025.00.
- 14.Direct Cremation: (Cremation Charge Extra) \$2,150.00 to \$8,145.00 This charge includes: 24 hour accessibility; general and administrative expenses; arrangements conference; planning, supervising, and coordinating service details; securing, preparing, and filing necessary documents; clerical and record keeping; other preparation of the body; transfer of remains; use of the hearse; local transportation to the crematory. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.
 - **A.** Direct Cremation with any casket selected from our funeral home (without any other services) \$2,150.00... with a casket from our selection room \$2,985.00 to \$6,285.00....**B.** Direct Cremation with a container or casket provided by the purchaser \$2,150.00....**C.** Direct Cremation with an alternative container \$2,350.00...**D.** Limited Service Direct Cremation: \$2,150.00 (for local service during regular business hours, M-F 8:00am to 5:00pm) includes: limited accessibility; limited general and administrative services; prepare and file necessary (certificate/permit/medical examiners permit) documents; cremation container local transfer with transportation to the crematory, cremation charge and no obituary.
- 15.Medical School Donation: \$ 1,195.00 this charge includes: 24 hour accessibility; general and administrative expenses; arrangements conference; planning, supervising, and coordinating service details; securing, preparing, and filing necessary documents; clerical and record keeping; other preparation of the body; transfer of remains; use of the hearse; local transportation to the medical facility.
