There are many options available when your choice of final disposition is cremation instead of burial. Below are a selection of services that many of our families consider for their cremation services. Services scheduled at Collins Funeral Home or any other facility may be subject to zoning restrictions and availability.

- 1. **Traditional Visitation and Church Ceremony.....\$ 7,300.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, use of facilities and staff for two-hour visitation at funeral home, funeral service at other facility, hearse and cremation fee.
- 2. **Traditional Funeral Home Chapel Service with Visitation One Hour Prior ..\$ 6,400.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, one extended service hour for visitation, funeral service at funeral home, and cremation fee.
- 3. **Traditional Visitation Service\$ 6,050.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, use of facilities and staff for two-hour visitation at funeral home, and cremation fee.
- 4. **Funeral Home Chapel Service with Visitation One Hour Prior\$ 5,300.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, one extended service hour for visitation, use of facilities and staff for funeral or memorial service at funeral home and cremation fee.
- 5. **Visitation Service.....\$ 4,950.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, use of facilities and staff for two-hour visitation at funeral home, and cremation fee.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff..... \$ 3,250.

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to the initial request for service; arrangement conference with family or responsible party; securing signed and certified copies of death certificate, recording vital statistics; preparation and filing of necessary authorizations and permits; staff assistance at all times, including consultation and coordination with those providing other portions of the funeral, e.g. church and clergy, cemetery, crematory, and others.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Transfer of Remains to Funeral Home \$ 650.

(Additional transportation fees apply beyond 50 miles)

Embalming \$ 800.

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Direct Cremation..... From \$ 4,200. to \$ 23,700.

The charge for a direct cremation includes transfer of remains to funeral home, basic services of the funeral director and staff and cremation fee. This charge does not include the use of the facilities and staff for any visitation or ceremony, public or private.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard covered wood box or cloth covered cardboard.

1. Direct cremation with alternative container (ACC) **\$ 4,500.**
2. Direct cremation with alternative container (Union)..... **\$ 5,000.**
3. Direct cremation with alternative container (Sebring) **\$ 5,200.**

Immediate Burial..... From \$ 4,750. to \$ 24,250.

Our charge for an immediate burial includes basic services of funeral director and staff, transfer of remains to funeral home, hearse, and equipment and staff for graveside service. It is our company policy that an immediate burial must take place within 48 hours of the time of death.

1. Immediate burial with minimum casket selected from funeral home **\$ 6,750.**
2. Immediate burial with casket provided by purchaser **\$ 4,750.**
3. Immediate burial with casket selected from funeral home (*see casket price list*) **\$ 4,750.**

Forwarding of Remains to Another Funeral Home \$ 3,500.

This charge includes transfer of remains to funeral home, basic services of funeral director and staff, embalming, minimum shipping container and transportation to local airport. This discounted service package does not apply to International Shipping of Human Remains, or any other services including visitation or ceremonies before forwarding of the body. This also does not include any airline charges, or additional preparation of the body services.

Receiving Remains from Another Funeral Home \$ 3,500.

This charge includes basic services of funeral director and staff, transfer of remains to funeral home, hearse, and equipment and staff for graveside service. This discounted service package does not include any visitation or funeral rite or ceremonies prior to graveside interment.
