The services offered, and related prices stated herein, are subject to change without prior notice. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral service arrangement you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items you may ask us to purchase for you - such as cemetery or crematory services, flowers, and newspaper notices. The prices for these items will be shown on your contract or statement describing the funeral goods and services you selected. Certain funeral services may be provided off premises by other funeral service providers.

Our funeral home is proud of our ability to accommodate unique or special requests, as well as funeral customs from the many diverse cultures present in our community. If there is a service which you would like for your loved one but do not see on our pricelist, please feel free to ask your Funeral Director and we will be honored to do everything we can to fulfill that request.

Hill and Wood Funeral Service offers Cremation Services, Attended Cremations, Burials and Green Burial Services. We do not offer "packages" like some of our competitors, beyond those required by the Federal Trade Commission, instead we price all of our services individually so you may pick only the services and offerings you choose. If a particular service is required, either by law or regulation, your Funeral Director will explain those charges and requirements, and if you would like, offer available alternatives.

### **I. PROFESSIONAL SERVICES**

#### **A. Professional services of Funeral Director and staff**

**\$4,405.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

Our charges include but are not limited to consultations with family and others, procurement, preparation and filing of necessary notices, authorizations and consents, custody of the decedent's body for up to seven days, cremation fee as selected, filing of the death certificate and obtaining permits, general expenses and supervision of minimum activities. This fee also includes an obituary on our website as well as an optional notice on 29 News, WVIR.

We also include bathing the deceased and dressing them with clothing provided by the family. We ask for a full set of undergarments with clothing. Hill and Wood Funeral Service is able to acquire clothing for an additional cost upon request. Cosmetology including both standard and

mortuary specific cosmetics; and placement of the deceased in the casket of the family's selection are also included in this cost as applicable. Also available to a family in this price are the option to have either a private time to say goodbye (limited to 15 family members and 45 minutes) or a private attended cremation, provided during daytime, weekday hours.

**B. Limited professional services when disposition has already occurred \$1,550.00**

This fee is for professional services for events when disposition has occurred elsewhere. This includes our basic services and overhead and will be added to the cost of funeral services selected. Our charges include but are not limited to consultations with family and others, procurement, preparation and filing of necessary notices and general expenses. This fee does not include our credit bureau notification service or obituary notices to WVIR. These can be purchased for an additional fee.

**C. Hill & Wood Staff Chaplain for services \$450.00**

At a family's request we can provide one of our chaplains to officiate a funeral or memorial service. Availability of our chaplains may vary. If you are considering this option, please consult with your funeral director.

**D. Hourly charge of Funeral Director and/or Staff for special or unique requests. \$150.00**

Hill and Wood will do everything we can to accommodate unique or special requests. Sometimes there is work involved in fulfilling such requests beyond our standard fees. In such cases there may be an hourly charge, shown here. Any such request should be discussed with your funeral director so they can provide an estimate, including an estimate of hours and any materials needed (materials, at cost, to be added separately). Only work related to requests that are unique or otherwise fall outside of our other professional services will fall under this category. Examples include, but are not limited to in-house construction of custom funeral or memorial items, in-house opening and closing of graves (as available), shopping for clothing, or other goods not offered by the funeral home, etc.

**E. Crematory Fee (When not using Professional Services) \$600.00**

**F. Weekend or Holiday Service Fee\* \$500.00**

This is an additional charge for funeral/memorial ceremonies that occur on a Weekend or Holiday.

**G. Advanced Service Reservation Fee\* \$250.00**

This charge is for reserving facilities and staff for ceremonies scheduled more than 14 days from the initial planning discussion.

\*Hill and Wood Funeral Service Policy is to not charge Weekend, Holiday, or Advance Service Reservation fees for families of veterans or their spouse, who are being interred at any National Cemetery if such fees are the result of delays at the cemetery rather than family choice.

## II. USE OF FUNERAL HOME FACILITIES, STAFF AND EQUIPMENT

### A. **Facilities and staff for visitation and viewing** **\$450.00**

Our charge includes supervision and attendants for visitation, receiving and displaying of floral arrangements, coordination and direction of requested visitation and use of parlor and other areas of our funeral home. This charge includes up to four hours of visitation concluding not later than 9 p.m. Longer visitations may be available at an additional charge of \$250.00/hr.

### B. **Facilities and staff for any of: Funeral ceremony, memorial service, graveside service or publicly attended cremation.** **\$995.00**

Our charge includes staff members to assist in services prior to and during the service requested. This includes up to two support vehicles, equipment for the requested ceremony, and the use of our facilities as needed.

### C. **Equipment and staff for committal following another service on same day.** **\$495.00**

Our charge includes staff members to assist in services prior to and during the requested service.

### D. **Refrigeration** **First day \$125.00, each additional day \$35.00**

This charge is for per-day refrigeration of the deceased; The first day charge and up to 6 additional days' charge is included in our Professional Services of Funeral Director and Staff. Refrigeration is required for decedents who are not embalmed and who are not buried or cremated within 48 hours of death. Embalmed decedents also require refrigeration after seven days. Hill & Wood will require embalming or other appropriate measures for any individual intended to remain in our care for more than 30 days, and relevant charges will apply.

### E. **Preplacement Fee - When no pallbearers provided by family** **\$350.00**

This fee is for Hill and Wood Staff, Cemetery or third parties, as well as their transportation, to move a casket from the Hearse or Memorial Vehicle to the place of service, or gravesite.

### F. **Scattering at sea or private property** **\$200.00**

Our fee for scattering of cremated remains by Hill and Wood Funeral Service, without family attendance. Includes certificate of date, time, and location of committal.

## III. EMBALMING

### A. **Embalming** **\$995.00**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as Direct Cremation or Immediate Burial.

Families electing Green Burial may request a "Green Embalming" using embalming fluids based on essential oils. As these fluids tend to be more expensive there is an additional charge. Families may also select to forego public viewings or have a vigil or viewing at home.

## **B. Additional Embalming Charges**

### **a. After-Hours**

**add \$150**

If an after-hours embalming is specifically requested or required to meet a deadline for travel, etc., Hill and Wood Funeral Service will accommodate such requests dependent on staff availability.

### **b. Green Embalming**

**add \$250**

Green Embalming is a service offered for families who desire embalming but are looking for a more environmentally sound option. Green Embalming follows the same procedures as "standard" embalming but uses fluids based on essential oils and other natural compounds that are more environmentally conscious. All embalming should be considered temporary, but Green Embalming, by design, is not meant to preserve the body for extended lengths of time. Your Funeral Director can advise you further if this is an option you are considering.

Our charge for styling hair, subject to availability and extent of request. Hill and Wood Funeral Service may complete requests either in-house or by hiring an outside professional; in either case it is possible that not all requests can be accommodated. Hill and Wood Funeral Service does not typically cut, perm, or dye hair; such services may be available for an additional fee.

## **V. IMMEDIATE BURIAL**

**\$5,945.00 to \$14,540.00**

Our charge includes local transfer of remains to funeral home, basic professional service of funeral director and staff, hearse or memorial vehicle to cemetery, and placement of the casket at grave. This does not include the requirements of the cemetery.

While we welcome a family member or representative being present to bear witness, this is limited to a single individual. If more than one individual wishes to be present this would require selection of a graveside service. Immediate Burials are conducted Monday through Friday only, at a time mutually convenient to the funeral home and cemetery. Given the reduced fees and staffing, we are not able to accommodate delays or ceremonies of any kind. "Immediate Burial" does not necessarily mean that burial will take place quickly.

## VI. DIRECT CREMATIONS

\$5,000.00 to \$13,595.00

Our direct cremation prices include our professional service of funeral director and staff, cremation fees, transfer of remains to funeral home, transfer of remains to crematory, a basic urn, and an optional private attended cremation service or private time to say goodbye (limited to 15 Family Members and 45 minutes).

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of wood reinforced cardboard, fiberboard or wood. We have included below the prices for direct cremation with an alternative container provided by the family as well as with each alternative container, as well as the most expensive casket suitable for cremation. Other options of both alternative containers and caskets suitable for cremation exist. Please see the alternative container price list or the casket price list for details.

This is our fee to guarantee Goods and Service on prearrangement funeral contracts. While the law allows us to charge up to 25% on the total preneed contract, we have arrived at 15% as a fair fee on goods and services only. This fee is charged on the preneed funeral contract when the family wishes to guarantee the funeral service at today's cost. It is used to help cover the cost of inflation and the unpredictable cost of doing funeral services in the future. This fee is only refundable if the preneed contract is transferred to another funeral home or if the preneed is canceled.

### **B. Preneed Repatriation Insurance**
