BASIC SERVICES OF FUNERAL DIRECTOR, STAFF, AND OVERHEAD..... \$3,900.00

Includes conducting the arrangement conference; planning services; consulting with family and clergy; obtaining necessary authorizations and permits; filing death certificates; preparing notices; coordinating services with cemeteries, crematories, and other providers; and overhead expenses.

This fee is **non-declinable**.

TRANSFER AND CARE OF REMAINS

Transfer of remains to the funeral home (local, within 40 miles)..... \$695.00

Additional mileage (outside 30 miles)..... \$3.50 per mile

Daily holding / refrigeration fee (after 48 hours)..... \$50.00 per day

EMBALMING..... \$875.00

Embalming is not required by law. Embalming may be necessary if you select certain arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require it, such as direct cremation or immediate burial.

Alternative containers encase the body and can be made of materials like **fiberboard or composition materials (with or without an outside covering)**. The alternative container we provide is a **cardboard cremation container**.
