



GENERAL PRICE LIST

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown inside are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you may select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Price is important. **NO ONE SHOULD PAY MORE THAN IS NECESSARY FOR ANY SERVICE.** You can be assured that our charges are based on actual expenses and that our total prices for cremations, urns and outer containers are very competitive. Even more important, you receive courteous, personalized service from a staff dedicated to meeting your needs; people who will take the time to listen and make sure that every detail is followed to completion.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery property, obituaries, etc. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

STATEMENT OF SERVICES

PROFESSIONAL SERVICES\$795.00

Non-declinable services of staff includes, but is not limited to: Staff to respond to initial request for service; arrangement and conference with family or responsible party; preparation of necessary authorizations and permits; including coordination with those providing other portions of requirements, i.e. crematory, transportation services. Also included in this charge are overhead expenses, secretarial and administrative costs, and equipment and inventory expenses.

TRANSPORTATION \$495.00

Includes removal from place of death locally. Other areas will be quoted depending on distance. There is an additional charge for evening, weekend, holiday and home removals.

CREMATION AND REFRIGERATION \$515.00

A few days will elapse from the time of death until cremation is completed. This time span necessitates a refrigerated holding facility, thus eliminating the need and cost of embalming.

BASIC CREMATION CONTAINER (sales tax not included) \$45.00

SPECIAL HANDLING AND CIRCUMSTANCES \$600.00

Additional charges will apply for oversize removal (and cremation).

TOTAL BASIC CREMATION COST \$1,750.00

Neptune Society makes every effort to have cremated remains ready in 5 to 7 working days. Certain circumstances, such as the Coroner's Office, government holidays and weekends could alter this time frame and cremation could take longer to accomplish.

 Use of funeral director for off site service within 10 miles for five (5) hours (each additional hour is \$200), use of a hearse for up to three (3) hours (each additional hour is \$150), embalming and dressing, and memorial book.

CAR AND DRIVER FOR EXPEDITED SERVICES \$400.00
 As noted above our services take between 5 - 7 working days, however, sometimes there is a need to expedite this time frame. If your request can be accommodated by this service, dedicated resources will work to reduce the time interval needed to normally complete our process. Typically, we can complete services within 3-5 days with this elective addition to our normal charges.

DIRECT CREMATION WITH CONTAINER PROVIDED BY PURCHASER \$2,000.00
 Our cremation container is the least expensive option for crematory acceptance. You can use an unfinished wood box or other upgrade combustible casket, or you can provide your own container or casket. All such containers must meet crematory requirements, includes disposition choice.
