However, any cremation arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing in the statement we provide describing the cremation goods and services you selected.

This list does not include prices for certain items that you may ask us to pay or buy for you, such as coroner fees, state fees, cemetery property, certified copies of death certificates, etc. The prices for those items will be shown on your statement describing the cremation goods and services you selected.

PROFESSIONAL SERVICES

~Non Declinable Services of Cremation Director.....\$795.00

This includes responding to initial request for services, arrangement in conference with family or responsible party, arrangement of cremation, preparation of necessary permits, staff assistance prior to, during, coordination with those providing other portions of the cremation, included is overhead expense relative to facility (insurance, maintenance and utilities, secretarial /admin costs, equipment and inventory).

~Transportation\$450.00

Includes removal from place of death locally. Other areas will be quoted depending upon distance. There is a \$50.00 additional charge for evening, weekend, holiday and residential care facility removals. (50 mile radius).

~Alternative Container.....\$ 85.00

~Cremation and Refrigeration.....\$640.00

A few days will elapse from the time of death until cremation is completed. This time span necessitates a refrigerated holding facility, thus eliminating the need and cost of embalming. Refrigeration \$50.00/day beyond 10 days.

There will be a certificate issued, listing date and location of scattering, mailed to responsible party.

(Chapel of the Light, Fresno CA or Skyview Memorial Lawn, Vallejo, CA)

3. Release to Family in minimal plastic urn.....\$245.00

OVERSIZED CASES (OVER 300 LBS)

WILL REQUIRE SPECIAL HANDLING FOR TRANSFER OF REMAINS TO CREMATION FACILITY. PALLET OR TRAY, AND CREMATION CAN ONLY BE DETERMINED AT TIME OF NEED.

Note:

Neptune Society makes every effort to have cremated remains ready in 8 to 14 business days. Certain circumstances such as the doctor, coroner, health department, government holidays and weekends could alter this time frame and cremation could take longer to accomplish.
