Our mortuary does not have "in house" financing or a monthly payment plan, nor does it accept or credit to the account any unverifiable assignments of funds by any governmental, public or private entity.

Basic Professional Services of Funeral Director and Staff

This is the basic fee that is charged to every family we serve for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing of necessary permits, consultation with the clergy, cemetery, crematory or common carrier, planning the funeral, and placement of obituary notices. There will be an additional charge for the direction and supervision of each service requested and required. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING

\$1,170.00

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by this state must complete this procedure. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for embalming such as direct cremation or immediate burial.
