Payment Policy

It is the policy of Piedmont Funeral Services that fees are paid in full 48 hours prior to services being rendered. We accept checks, cashier checks and credit cards.

Pre-Need Arrangements Disclosure

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

Basic Services Price

Basic Services (Consultation, Administration and Overhead)

Our services include: conducting the arrangements conference, consulting with family and clergy; shelter of remains; obtaining domestic certificates and burial permit; coordinating with the cemetery or crematory. Additionally, this fee includes a share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

Exclusions: Basic services excludes staff, equipment and facilities for visitations, memorial services and funerals, catering, gatherings and related events; embalming and preparation other than Minimal Services, casket, urn, transportation of Decedent, family or others; cremation, shipping arrangements and shipping costs, cash advance items and other third-party charges and other goods and services.

If you choose to itemize your services and merchandise, this fee is added to your total costs. If you choose one of our packages, then this fee is included in the package price.

Embalming Disclosure

Except in certain special circumstances, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to (buy and) pay for it, such as direct cremation or immediate burial.

Embalming includes bathing, sanitary procedures and replacement of body fluids by chemicals to produce a temporary enhanced presentation.

Our service includes planning and management of the Funeral Services at the Cemetery's Tower or Main Mausoleum Chapel, or another location; which includes transportation of the Decedent and flowers to the chapel and cemetery; but excludes transportation of others. Disclosure: Airlines and other common carriers require embalming and secure packaging of the decedent's remains.

Forwarding of Remains to Another Funeral Home (a "minimum" service)

Our charge includes: Basic Services of funeral of director and staff; a proportionate share of overhead costs, removal of remains, embalming or other preparation of remains, if relevant; and transportation to local airport or other places of shipment within 40 miles.

Exclusions: Transportation more than 40 miles, international arrangements (see below), air tray, casket, urn, funeral or memorial services, viewing or other services and merchandise.

Receiving Remains from Another Funeral Home (a "minimum" service)

Our charge includes: Basic Services of funeral of director and staff; a proportionate share of overhead costs; care of remains; transportation of remains from local airport within 40 miles or other shipping destination; and transportation to cemetery or crematory.

Immediate Burial

Our charge for an immediate burial (without ceremony) includes: Basic Services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.

Exclusions: Casket, embalming, visitation, memorial or funeral services, and other goods and services. 2,680.00

Direct Cremation

Our charge for a direct cremation (without ceremony) includes: Basic Services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations; and cremation.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative container we offer is a cardboard cremation container.

Exclusions: Urns, visitation, funeral and memorial service, transportation to cemetery, columbaria or residence and other goods and services.
