BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF (OVERHEAD) (Non-Declinable)\$2,395.00*

Our charge for basic services includes, but is not limited to, the services of our funeral directors and staff to respond to the initial request for service; the arrangements conference with the family or responsible party; arrangement of the funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; assistance of staff prior to, during and following the funeral, including coordinating service times with a cemetery, crematory and any other third parties involved; receiving and arranging flowers and customary sheltering of the deceased. Included in the charges are our overhead expenses for operating this funeral home, such as responding 24 hours a day to calls, accounting and billing for services, secretarial and administrative costs, maintenance, taxes and utility expenses, equipment and inventory expenses, insurance expenses and other overhead expenses. This fee also includes a portion of the cost to sponsor and support various seminars, aftercare services and community projects by our funeral homes. **The fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (A portion of this fee is already included in our charges for cremations, immediate burials and forwarding or receiving remains.) (A portion of the basic service fee is added to our fee for cremation or body donation for medical research.)**

EMBALMING.....\$575.00*

Except in certain special cases, embalming is not required by law. Embalming is required by Pulliam Funeral Homes if you select funeral arrangements, such as a funeral with public viewing of the deceased. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or burial within 24 hours. We will answer any questions you may have regarding our embalming procedures.

Our charge for this service includes local transfer of remains to our funeral home (within 15 mi radius) embalming, basic services of Funeral director and staff and preparation of necessary permits. This charge does not include a shipping container, viewing, ceremony, long distance ground transportation or mileage to an airport or the actual airline shipping charges.
- RECEIVING OF CASKETED REMAINS FROM ANOTHER FUNERAL HOME..... \$2,195.00**
Our charge for this service includes basic service of funeral director and staff, safekeeping of the body. This charge does not include funeral or burial merchandise, viewing, funeral or graveside services, newspaper obituaries, long distance transportation from an airport or funeral home, flowers, cemetery spaces, grave opening & closing or clergy or music honoraria.
- RECEIVING OF CREMATED REMAINS FROM ANOTHER FUNERAL HOME OR CREMATORY OR FROM THE FAMILY OF THE DECEASED.....\$250.00**
Our charge for this service includes necessary services of funeral director and staff, a proportionate share of over-head costs, temporary shelter and care of the cremated remains, and local transportation to the place of final disposition. This charge does not include visitation in our facilities, graveside or funeral ceremonies in our facilities, grave opening, Clergy honoraria, obituaries or any memorial merchandise.

Our charge for this service includes local transfer of remains to funeral home, basic services of funeral director and staff, necessary permits and transfer to a local cemetery (within a 15-mile radius). Funeral Home will provide minimum casket or container as well as required grave liner (box). Purchasers must pay grave opening fees. No visitation/viewing, funeral services or graveside services are provided with this option. (Add \$575.00 for embalming, if desired)

Our charge for this service includes transfer of the remains to the funeral home as required at time of death and a proportionate share of over-head costs. This charge includes necessary permits, **NOTE: Prior acceptance of the remains by the medical facility will be required BEFORE transport to a medical school.** This charge does not include visitation rites or ceremonies prior to the transportation of body to a medical school. These services are available for an additional charge.
- NOTE: Most medical schools and anatomical facilities will require local embalming. Visitation and funeral services are encouraged prior to body bequeathal. Bequeathal following a full-service funeral and visitation, using one of our ceremonial caskets, will be \$950.00 in addition to traditional service charges. We will answer any questions you may have regarding donations of the human body.**

Cremation Service Offerings

Cremation is the process of reducing the body of the deceased to fragments of bone by way of heat and flame. We prefer to use "cremated remains" rather than the terms "ashes" or "cremains" because we believe that those terms are misleading. We will be pleased to answer any questions you might have regarding cremation. Pulliam Funeral Homes, P.C., requires identification of the deceased by the next of kin or their representative prior to cremation.

Our charges for this selection include services of funeral director and staff, death certificate and burial permit prep, embalming, cosmetology, casketing of body and general use of facilities local transportation of deceased plus the following: Reduced cremation fee, Use of Norwood or Batesville Oak Ceremonial Casket, two hours of visitation with funeral services the same day in our facility and graveside committal of cremated remains (local). We offer for purchase Register Books, Personalized Memorial Folders and Acknowledgement Cards. Urns for burial or inurnment of cremated remains, cremation jewelry, honoraria, flowers, grave opening charges, certified copies of death certificates, monument updates and newspaper obituaries are extra. *****See URN price list under separate cover.

DIRECT CREMATION WITH A MEMORIAL SERVICE IN OUR CHAPEL OR OTHER VENUE.\$3,895.00*

This charge includes local transfer (15 mi) of the decedent to our funeral home, removal of medical appliances, minimum services of funeral director and staff, a proportionate share of overhead cost, transfer to our crematory and normal cremation charges. This charge does not include the Coroner/Medical Examiner's permit to cremate, funeral or memorial services, public viewing, embalming, grave opening or inurnment charges nor U.S.P.S. postage & packaging for shipment of remains. Cremated remains will be held in a temporary plastic container for sixty (60) days without charge. Cremated remains abandoned at our facility will be interred in a local cemetery of our choosing, in accordance with state law without ceremony or memorialization. If you want to arrange a direct cremation, you may provide an alternative container. Alternative containers encase the body and can be made of materials like wood, fiberboard or composite material No Nails or Staples Permitted. The alternative containers that we provide are for cremation only, and are re-enforced waterproof cardboard receptacles with no outside embellishment and capable of handling a maximum of 325 lbs.
